

HOA's - Always follow fair procedure!

In the recent case of *Bella Rosa Three Home Owners Association v Brandt* [2024] ZAWCHC 267, the Western Cape High Court reinforced a crucial point for Homeowners' Associations (HOAs) and property owners alike: the importance of always following fair and transparent procedures when making decisions that affect homeowners. The case serves as a significant reminder that, even in the context of community living, due process and fairness must not be overlooked.

Background of the Case

The dispute in *Bella Rosa Three Home Owners Association v Brandt* arose when the HOA took steps to enforce certain rules and regulations within the estate, which were in place to preserve the quality of life for its residents. The homeowner, Brandt, challenged the actions of the HOA, alleging that the association did not follow the proper procedures when making decisions that impacted his property rights.
